# Construction contracts & FIDIC

Comprehensive legal advice for all entities involved in infrastructure projects based on construction contracts, including contracting under FIDIC conditions.

- we draft and advise on construction contracts, subcontracts, design contracts, agreements for design supervision, investor supervision, and contract engineer services;

- We provide legal assistance in negotiation of contract conditions between the parties and with financial institutions;
- We advise on appointment of contractors for construction work and verify contractors' bids;

We carry out revisions of company labour law in an enterprise, including the verifications of employee documentation, labour rules, payroll rules, and the Company Social Benefit Fund.

Woziński Kulisz Law Firm renders comprehensive consulting services concerning individual and collective labour law.

Such services include:

- Group and individual reductions;
- Drawing up employee documentation, including contracts of employment, non-compete clauses, and management contracts;
- Resolving employee disputes (including in courts).

# Public procurement

The law firm holds considerable experience of public procurement law, which stems from consulting both for clients and contractors.

We offer services during the process of awarding and obtaining public procurements. Acting on behalf of the Client, we participate in the preparation and conduct of public procurement.

- The verification of ToR with regard to violating the principles of fair competition and equal treatment of contractors;
- Preparing draft questions about ToR;
- Drawing up appeals and complaints to court;
- Participating in appeal procedures;
- Representing the contractor at meetings and hearings before the National Chamber of Appeal in Warsaw;
- Representing the contractor in procedures before the regional court in appeals against decisions of the Chamber.
